### WEST BENGAL ELECTRICITY REGULATORY COMMISSION

### NOTIFICATION

No. 14/WBERC Dated: 23.03.2004

In exercise of the power conferred on it by section 181 read with sub-section (2) and sub-section (3) of section 91 of the Electricity Act, 2003 (No.36 of 2003) and all powers enabling it in that behalf, West Bengal Electricity Regulatory Commission hereby makes the following regulations:

## Short title, commencement and interpretation

(i) These regulations may be called the West Bengal Electricity Regulatory Commission (Number, Nature and Categories of Other Employees Salaries, Allowances and Other Conditions Service of Secretary, Other

Officers and Employees) Regulations, 2004.

- (ii) They shall come into force on the date of their publication in the Official Gazette. However, in respect of Secretary, other officers and employees already appointed by the Commission these regulations be shall deemed to come into force from the date of their initial appointments in commission.
- (iii) The General Bengal Clauses Act, 1899(Ben, Act I of 1899) shall apply to the interpretation of

these regulations unless otherwise indicated in these Regulations.

### 2. Definitions

THE RESIDENCE OF THE

- 1) In these Regulations, unless the context otherwise requires:
  - a) The Act means the Electricity Act, 2003 (36 of 2003)
  - b) Chairperson means the Chairperson of 3. the Commission

  - d) Employees means such persons appointed against the post as categorized as staff in the annexure.
- all ve battaloga e) by Officers means such persons appointed against the post as categorized as officer in the annexure.
- f) Regulation means a Regulation made under the Act;

- g) State Govt. means the Govt. of West Bengal.
- h) Secretary means the Secretary of the Commission.
- 2) Words and expressions occurring in these Regulations and not defined herein above shall bear the same meaning as in the Act, Rules and Regulations.
- The number, nature and categories of other officers and employees of the Commission shall be such as mentioned in the schedule.
- 4. Salaries and other allowances of the Secretary, other officers and employees in the Commission:
  - i) Salaries and other allowance of the Secretary, other officers and employee shall be such as specified in the schedule.
- The remuneration to be ii) paid to the persons appointed on contract basis shall be such as may be determined by the Commission from time to time. It may be in the form of a consolidated pay or otherwise as may be the determined by Commission. The Commission may keep in view amongst other factors the last pay drawn by the person and the pension being drawn by him.
  - The officers and staff appointed on deputation

shall be entitled to such salary and allowances as are admissible as per the rules of the State Govt.

#### 5. Method of selection and conditions appointment

- Officers and staff may be appointed by the Commission in any of the following ways:
  - a. Direct recruitment through open advertisement.
  - On deputation from Central Government /State Government / Power Utilities/ Other Organization as decided by the. Commission
- c. By promotion as may be decided by the Commission.
  - d. Contract basis.
- Commission The shall ii) determine the age. qualifications and experience for each post from time to time. The age of retirement will be the same as that in the state government for regular employees.
- iii) The persons selected for appointment must physically fit and be persons of integrity and no person shall be appointed on regular basis without verification of antecedents.
- iv) the case of appointment on regular basis. the rules of

- reservation as applicable in the State Govt, shall be followed.
- onthe v) The Commission shall from time to time constitute selection committees to recommend the names for appointment against various posts. The Selection Committee shall consist of not less than three persons.
- vi) The Appointing authority and the reviewing authority shall be the Commission in respect of the officers and employees of the Commission: The disciplinary authority and the appellate authority for various grades of posts shall be decided by the chairperson.
  - vii) Subject to the other provisions stipulated in these regulations, other service conditions applicable to the officers and employees shall be the same as are applicable in the State Govt.

#### Saving and general powers: 6.

i) Nothing in these Regulations shall be deemed to limit OF otherwise affect the inherent powers of the Commission to make such orders as may be necessary subject to approval of the State Govt. wherever required under the Act.

- ii) Nothing in these Regulations shall bar the Commission adopting a procedure which is at variance with any of the provisions of the Regulations, if Commission, in view of special circumstances and reasons to be recorded in writing, deems necessary or expedient subject to the approval of the State Govt.
- iii) The Commission may at any time amend or modify the schedules at the sole discretion subject to the approval of the State Govt.

- B. Dearness allowance, HRA, CCA, Deputation Allowance etc. shall be as per the entitlement, of equivalent officials in the State Government.
- C. Leave and other conditions of service shall be the same as applicable to officials/employees of the State Govt. having equivalent grade.
- D. The medical allowance will be as is admissible in the State Govt.
- E. Transport: the vehicles as may be required may be hired for the Secretary and other officers with the approval of the chairperson at the rates approved by the transport deptt. of the State Govt. from time to time. Other orders as applicable in the State Govt, shall also be followed in the Commission.
- F. Security and cleaning staff etc. subject to a maximum of four persons (in all) may be engaged by the Commission on contract basis as and when required.
