CASE IN BRIEF

- 1.0 The Commission vide order dated 25.09.2017 in case no. APR-54/15-16 passed the following direction to DVC:
 - i) DVC will submit revised petition for APR 2014-2015 after incorporating tariff passed by the Central Electricity Regulatory Commission for the tariff period 2014-19 for the different generating stations of DVC as well as the tariff for composite transmission and distribution network of DVC.
 - ii) The revised petition for APR 2014-15 should be submitted immediately after receipt of tariff order issued by the Central Commission in respect of the composite transmission and distribution network of DVC.
 - iii) APR petition filed by DVC for 2014-15 on 22.02.2016 shall be kept pending till submission of revised petition by DVC as stated in (i) and (ii) above.
- 2.0 Whereas it has been brought to the notice to this Commission that the Central Electricity Regulatory Commission (in short 'CERC') has passed tariff orders in respect of generating stations of DVC for the period 2014 to 2019. CERC has also passed truing up of transmission tariff of 2014 to 2019 in respect of the existing Transmission and Distribution (T&D) system of DVC vide their order dated 10.06.2022. The input tariff cost thus finalized by CERC actually constitute the major component of Aggregate Revenue Requirement (ARR) of DVC for distribution in their licensed area.
- 3.0 DVC accordingly is required to file revised petitions of Annual Performance Review (APR) for the years 2014-15 to 2016-17 duly incorporating the determined tariff of CERC as referred above.

ORDER

4.0 DVC in supersession of any previous direction is directed to file the revised petition of Annual Performance Review for the years 2014-15 to 2016-17 within 14 days from the date of this order failing which the Commission shall proceed in terms of regulation 2.6.7 of the West Bengal Electricity Regulatory Commission (Terms and

Condition of Tariff) Regulations, 2011, as amended to determine the cost to avoid front loading of tariff / tariff shock to the consumers.
