			1.0 One Md. Moinul Haque, S/o Late Khorshed Mandal, Vill. Lakshminarayanpur, P. O. Kolan Radhakantapur, P. S. Ranitala, Dist. Murshidabad, PIN 742123, West Bengal (hereinafter referred to as the "Complainant") approached the West Bengal Electricity Regulatory Commission (hereinafter referred to as the "Commission") with an application dated 02.03.2020 stating that the Ombudsman, West Bengal Electricity Regulatory Commission appointed under Section 42(6) of the Electricity Act, 2003 (hereinafter referred to as the "Act"), had in his settlement order dated 26.03.2015 issued certain directions to the West Bengal State Electricity Distribution Company Limited (in short "WBSEDCL") and the same was forwarded to them vide letter no. OMBUD/W-488 SB/2014/815 dated 03.03.2015 of Office of the Ombudsman.
			Md. Moinul Haque alleged vide his application to the Commission for non-compliance with the Order dated 26.03.2015 of the Ombudsman by WBSEDCL.
	dikity Regulati		2.0 On perusing the contents of the petition filed by the Complainant and or going through the documents submitted by the Complainant the Commission was of the view that the matter required careful examination. The Commission admitted the matter and decided to hold an e-hearing and served notices to both the Complainant and WBSEDCL (the licensee) under no. WBERC/Comp/WBSEDCL/426/19 20/274(I-II) dated the 10 th February, 2021 intimating that the e-hearing was to be held on 22.03.2021 at 15.00 hours.

- Roy, Chief Engineer, CRM Cell, WBSEDCL was present during the meeting. The complainant (or his representative) did not attend the ehearing.
- 4.0 During the hearing, Sri Subhashis Roy, on behalf of WBSEDCL, submitted that WBSEDCL has already complied with the direction of the Ld. Ombudsman given in his order dated 26.03.2015. In this context, a compliance report dated 30.12.2020 is stated to have already been submitted by WBSEDCL to the Commission. However, the said compliance report could not be traced in the file.
- 5.0 On request from the Commission, Sri Roy read out the compliance report, in question, which inter-alia says as under:
 - i) The defective meter has been replaced;
 - ii) The bills have been regenerated after adjustment;
 - iii) The complainant has not yet applied to WBSEDCL for allowing the complainant for making outstanding payments in instalments.
- 6.0 On query from the Commission, Sri Roy also clarified that the complainant has neither made the payments of the regenerated bill nor he is making payment of the current bills. Till date the outstanding amount has been mounted to the tune of Rs. 27,321.00 and Late Payment Surcharge to the tune of Rs. 13686.00. Although the complainant has not been making payment of the outstanding bill, the service connection of the complainant is still in live
- 7.0 The Commission after hearing the submissions by WBSEDCL opined that WBSEDCL may provide a further copy of the compliance report dated 30.12.2020 and accordingly it was decided that –
 - a) WBSEDCL shall submit a copy of the compliance report dated 30.12.2020 to the Commission within 3 days.
