HEARING NOTICE

WHEREAS, a petition was submitted by M/s Phillips Carbon Black Limited through Mr. Rishav Dutt, Advocate, Khaitan & Co LLP vide letter no. SNM/RD dated 20.07.2020 under Section 86 (1) (F) read with Section 86 (1) (A) of the Electricity Act, 2003 for adjudicating upon dispute between the Petitioner and West Bengal State Electricity Transmission Company Limited (WBSETCL) and West Bengal State Electricity Distribution Company Limited (WBSEDCL).

AND WHEREAS, letter of West Bengal Electricity Regulatory Commission (WBERC) vide WBERC/OA-341/20-21/134-135 dt 18.01.2021 directed to WBSETCL and WBSEDCL to kindly submit para wise views / comments on the application of M/s Phillips Carbon Black Limited within fifteen (15) days from the date of receipt of the letter. WBERC has also forwarded a copy of the petition of M/s Phillips Carbon Black Limited to WBSETCL and WBSEDCL through e-mail for their necessary action.

AND WHEREAS, In response to WBERC letter dated 18.01.2021, a request for extension of time requires further three weeks for submission of para wise reply has been received from WBSEDCL vide letter no. REG/SERC/Open Access/45 dt 09.02.2021.

AND WHEREAS, only WBSEDCL has submitted their reply with affidavit vide letter no. REG/SERC/PCBL/70 dated 02.03.2021.

Now, therefore, the undersigned is directed by the order of the Commission to issue this NOTICE for giving a hearing to the parties concerned on 07.09.2021 at 14.30 PM on line. Two persons each from respondent / petitioner will be allowed to participate in on line hearing. Mail IDs of such persons are to be submitted to the Secretary at least one day before the scheduled hearing date alongwith an authorization in Form 3 as per provision of the West Bengal Electricity Regulatory Commission (Conduct of Business) Regulation 2013.
