NOTICE FOR HEARING

WHEREAS, Sk. Abu Toraf, Vill- Banagarh, PO- Natunhat, PS- Mondalkote, Dist- Purba Bardhaman, PIN - 713147, Mobile No: 9735273005 alleged that WBSEDCL has not compiled with the order dated 04.09.2018 of the Ld. Ombudsman, West Bengal, appointed under Sec 42(6) of the Electricity Act, 2003, in GR Case No W-135 SSS/2017 followed by Ld. Ombudsman's communication No OMBUD/W-125 SSS/2017/1295 dated 30.10.2018.

AND, WHEREAS, Sk. Abu Toraf, Vill- Banagarh, PO- Natunhat, PS- Mondalkote, Dist- Purba Bardhaman, PIN – 713147, Mobile No: 9735273005, has brought to the notice of the Commission vide his application dated 12.06.2019 under Section 142 of the Electricity Act, 2003 with regard to the non-compliance of Order dated 04.09.2018 of the Ld. Ombudsman.

Now, the undersigned is directed by order of the Commission to issue this NOTICE for giving online hearing to West Bengal State Electricity Distribution Company Limited (WBSEDCL), at 12.04.2021 and to convey that the said hearing be attended as per schedule. If West Bengal State Electricity Distribution Company Limited (WBSEDCL), is unable to themselves in the hearing as aforesaid and wish to be Distribution Company Limited (WBSEDCL), is unable to themselves in the hearing as aforesaid and wish to be the represented by someone else, the representative shall have to produce an authorization in Form 3 as per provisions of regulations 2.10.7 of the West Bengal Electricity Regulatory Commission (Conduct of Business), Regulations, 2013 by 2PM on 17.02.2021.

In case West Bengal State Electricity Distribution Company Limited (WBSEDCL), upon whom Notice is being served, do not attend the hearing, either by self or through representative duly authorized as aforesaid, the Commission may in terms of Regulation 2.13 of the aforesaid Regulations at its discretion may proceed ex-parte to decide the matter by following the procedure established by law.

Attention of the Chairman and Managing Director, WBSEDCL is also drawn to the desire of the Commission that the licensee be represented by someone who is conversant with the facts and circumstances related to the matter as also with the provision of the law and Regulations. If the licensee authorizes an officer of related to the matter as also with the provision of the law and Regulations. If the licensee authorizes an officer of its own to represent itself in the proceedings, he/she should usually be an officer not below the rank of a Chief Engineer.
