## NOTICE FOR HEARING

WHEREAS, Md. Moinul Haque, S/O Late Khorsed Mandal, Vill- Lakshminarayanpur, PO- Kolan Radhakanta Pur, PS- Ranitala, Dist- Murshidabad, PIN – 742123, Mobile No 9002107001 alleged that WBSEDCL has not complied with the orders dated 26.03.2015 of the Ld. Ombudsman, West Bengal, appointed under Sec 42(6) of the Electricity Act, 2003, in GR Case No W-488 SB/2014 followed by Ld. Ombudsman's communication No OMBUD/W-488 SB/2014/815 dated 30.03.2015.


AND, WHEREAS, Md. Moinul Haque, S/O Late Khorsed Mandal, Vill- Lakshminarayanpur, PO- Kolan Radhakanta Pur, PS- Ranitala, Dist- Murshidabad, PIN – 742123, Mobile No 9002107001, has brought to the notice of the Commission vide his application dated 02.03.2020 under Section 142 of the Electricity Act, 2003 with regard to the non-compliance of Order dated 26.03.2015 of the Ld. Ombudsman.

Now, the undersigned is directed by order of the Commission to issue this NOTICE for giving a hearing to West Bengal State Electricity Distribution Company Limited (WBSEDCL), at **3 PM on 22.03.2021** and to convey that the said hearing be attended as per schedule. If West Bengal State Electricity Distribution Company Limited (WBSEDCL), is unable to themselves in the hearing as aforesaid and wish to be represented by someone else, the representative shall have to produce an authorization in Form 3 as per provisions of regulations 2.10.7 of the West Bengal Electricity Regulatory Commission (Conduct of Business), Regulations, 2013 by 2PM on 22.02.2021.

In case West Bengal State Electricity Distribution Company Limited (WBSEDCL), upon whom Notice is being served, do not attend the hearing, either by self or through representative duly authorized as aforesaid, the Commission may, in terms of Regulation 2.13 of the aforesaid Regulations at its discretion may proceed ex-parte to decide the matter by following the procedure established by law.

Attention of the Chairman and Managing Director, WBSEDCL is also drawn to the desire of the Commission that the licensee be represented by someone who is conversant with the facts and circumstances related to the matter as also with the provision of the law and Regulations. If the licensee authorizes an officer of its own to represent itself in the proceedings, he/she should usually be an officer not below the rank of a Chief Engineer.


