## EMPLOYMENT NOTICE

Applications are invited from Indian Nationals for appointment as Ombudsman as per the provisions of Section 42 (6) of the Electricity Act, 2003. Such appointment shall be temporary for the first six months and subject to rendering satisfactory service during the first six months, the tenure may further be extended from time to time subject to a maximum of four and a half years or till the person concerned attains the age of 65 years, whichever is earlier.

For discharging the functions of the Ombudsman remuneration will be paid as per the conditions of service of the Ombudsman as stated in WBERC (Guidelines for Establishment of Forum for Redressal of Grievances of Consumers and Time and Manner of Dealing with such Grievances by the Ombudsman) (First Amendment), Regulation, 2020.

The candidates have to satisfy the following conditions :

### Essential Qualifications:

1. The candidate must be a person of ability, integrity and standing with a graduate degree in any discipline including law, with a minimum experience of 25 years of service in the Government departments holding the position not below the rank of Special/Additional Secretary or (ii) Secretary/Advisor/Director or equivalent in any regulatory body or (iii) in the Judicial Department holding the post not below the rank of District Judge (entry level);
2. Age of the candidate should not be less than 55 years but not more than 63 years as on **01/12/2020**.

### Desirable Qualifications:

1. Discharging Judicial functions or quasi-judicial functions in the Government departments/Public administration OR
2. Exposure in the power sector OR
3. Experience of holding hearing of public grievances against specific complaints filed under different provisions of law and passing reasoned orders.

Candidates in possession of above mentioned qualifications may submit application in plain paper through ordinary postal service/courier/ messenger addressed to the Secretary of the Commission and must enclose (a) Bio-data with contact phone number and email ID; (b) self attested testimonials of educational qualifications and age, (c) a detailed note on experience with posts held and functions discharged in respect of each such post with duration thereof.
