In exercise of the powers conferred by sub-section (1) and (2) of section 181 read with sub-section (1) of section 92 of the Electricity Act, 2003 (36 of 2003) and all powers enabling in this behalf, the West Bengal Electricity Regulatory Commission hereby makes the following regulations to amend the West Bengal Electricity Regulatory Commission (Conduct of Business) Regulations, 2013 published under notification no. 59/ WBERC dated 11th September, 2013 (hereinafter referred to as the "Principal Regulation").

1. Short title, extent and commencement:

- 1.1. These Regulations may be called the West Bengal Electricity Regulatory Commission (Conduct of Business) (First Amendment) Regulations, 2021.
- 1.2. These extend to the whole of the West Bengal.
- 1.3. These shall come into force on the date of their publication in the Official Gazette.
