- The application in the prescribed format as per Annexure- II duly filled in may be sent to the Secretary, West Bengal Electricity Regulatory Commission, Plot No - AH/5, Premises No. MAR 16-1111, Action Area - 1A, New Town, Rajarhat, Kolkata - 700163 within 24.06.2022 at 5 (PM). A copy of the application may also be e-mailed but hard copy with due authentication / signature is essential.
- For candidates who are engaged or working in Govt./ Semi Govt./ PSU, applications should be accompanied by a 'No Objection Certificate' from their parent department / institution within the last date of submission of application.
- 5. Incomplete application or application submitted in different format is liable to be summarily rejected.
- 6. Short listed candidates based on their educational qualification, experience etc. will be called for personal interview.
- The selected candidate for engagement on contract basis shall be on observation for a period of six (6) months. Based on the satisfactory performance of the selected candidates during the observation period the selected candidate will be considered for engagement for a further period of one year and maximum three years up to the age of 65 years, whichever is earlier.
