The objective is to carry out intensive audit of the circumstances in which WBSEDCL has continued without recovery of the Regulatory Assets.

# Instructions to Bidders (ITB)

# 1. General

- 1.1 West Bengal Electricity Regulatory Commission (WBERC) invites sealed bids from eligible and qualified bidders for empanelment to carry out intensive audit of West Bengal State Electricity Distribution Company Limited (WBSEDCL).
- 1.2 The bidding process shall be governed by this ITB, the Request for Proposal (RFP), and all annexures issued under this RFP.
- 2. Eligibility of Bidders
- 2.1 The bidder(s) must meet all eligibility criteria specified in Section 4 of the RFP.
- 2.2 Joint ventures or consortiums are not permitted.
- 3. Cost of Bidding
- 3.1 The bidder(s) shall bear all costs associated with preparation and submission of the bid. WBERC will not be responsible or liable for such costs regardless of the outcome of the bidding process.
- 4. Clarifications
- 4.1 Prospective bidders requiring any clarification on the bidding documents may notify WBERC via email before the deadline for seeking clarifications.
- 4.2 WBERC will upload the clarification restricting to the contents of the RFP document in the website of the WBERC.
- 5. Bid Preparation
- 5.1 Bids shall be prepared in two parts: Part A (Techno-Commercial) and Part B (Price Bid).
- 5.2 Part A shall include covering letter, eligibility documents, methodology, CVs, and annexures as required, in a sealed envelope mentioning the details of the bidder and marked Part A.

- 5.3 Part B shall include the price bid in the prescribed format in a sealed envelope mentioning the details of the bidder and marked as Part B.
- 5.4 The bid shall be also accompanied with a sealed envelope marked as "EMD" containing EMD of Rupees 50,000/-.
- 5.5 All documents must be signed by an authorized signatory of the firm.
- 6. Bid Security (EMD)
- 6.1 An Earnest Money Deposit (EMD) of INR 50,000 must accompany the bid in the form specified in the RFP.
- 6.2 Bids without EMD shall be rejected.
- 6.3 EMD will be forfeited if the bidder withdraws, modifies or fails to submit the acceptance letter within 7 days from the date of issue of Letter of Award.
- 7. Submission of Bids

- 7.2 Late bids will not be accepted.
- 7.3 Part A, Part B and EMD must be sealed in separate envelopes and placed inside a larger envelope, clearly marked with tender number and name of the bidder.
- 8. Opening of Bids
- 8.1 Part A will be opened at the specified date and time in the presence of bidders' representatives who choose to attend.

- 8.2 Part B will be opened only for technically qualified bidders at a later date, as notified by WBERC.
- 9. Evaluation of Bids
- 9.1 Evaluation will be carried out as per criteria detailed in the RFP.
- 9.2 WBERC reserves the right to seek clarifications and additional information from bidders during evaluation.
- 9.3 Any tender found incomplete and/or non-responsive shall lead to outright cancellation of the tender.
- 9.4 Any engagement/involvement/assignment/appointment with WBSEDCL presently and during three preceding financial years will lead to cancellation of bid.
- 10. Award of Contract
- 10.1 The contract shall be awarded to the bidder declared as the L1 bidder.
- 10.2 WBERC reserves the right to accept or reject any bid, annul the bidding process, or award partial work without assigning any reason.
- 11. Performance Security
- 11.1 The EMD of the bidders selected for empanelment shall be held as Performance Guarantee.
- 11.2 EMD of the unsuccessful bidders shall be refunded after finalization of the RFP.
- 12. Corrupt or Fraudulent Practices
- 12.1 Bidders shall observe the highest standard of ethics during the execution of the contract.
- 12.2 Any attempt to influence the evaluation process shall result in rejection of the bid and blacklisting.
- 12.3 Any evidence of collusion or formation of cartel shall lead to outright cancellation of the bid.
- 12.4 Canvassing in any form shall lead to outright cancellation of the bid.

# 13. Governing Law

13.1 The bidding process shall be governed by the laws of India and subject to the jurisdiction of courts in Kolkata.

#### 1. Introduction

West Bengal Electricity Regulatory Commission (WBERC or Commission) had earlier invited proposals vide Tender No. WBERC/C-24/2/549 dated 23.09.2025, from eligible, experienced and reputable audit firms for empanelment to carry out intensive audit of its Distribution Licensees in compliance with the order of the Hon'ble Supreme Court in Case Number Writ Petition (Civil) No.104 of 2014 and batch dated 06.08.2025. In view of inadequate response in respect of West Bengal State Electricity Distribution Company Limited (WBSEDCL), WBERC invites proposals again from eligible, experienced and reputable audit firms for empanelment to carry out intensive audit of its Distribution Licensee —West Bengal State Electricity Distribution Company Limited (WBSEDCL), in compliance with the order of the Hon'ble Supreme Court in Case Number Writ Petition (Civil) No.104 of 2014 and batch dated 06.08.2025. The objective is to carry out intensive audit of the circumstances in which WBSEDCL has continued without recovery of the Regulatory Asset.

### 2. Tender / Bid Submission (Two-Part)

This is a two-part tender comprising:

Part A - Techno-Commercial Proposal;

Part B – Price Proposal.

Part A will be opened first and only those bidders who qualify in Part A will have their Part B opened.

### 3. Scope of Work

A. Intensive audit of the circumstances in which WBSEDCL has continued without recovery of the Regulatory Asset.

- B. Extant Regulatory Assets from its inception as per relevant orders issued by the Commission from time to time.
- C. Identify the source of funding for functioning and continuation of operation without recovery of the Regulatory Asset.
- D. Examination of relevant documents as may be felt necessary during the course of intensive audit.
- E. Preparation of interim and final reports with clear and explicit findings.

### 4. Eligibility & Qualification Criteria

Registered Chartered Accountant/Cost Accountant firm with at least 10 years in business

- a) At least 3 assignments in last 7 years from the date of publication of this RFP, involving audit of utilities engaged in Generation/Transmission/Distribution of electricity (Cumulative value ≥ INR 20 lakhs for such assignments).
- b) Average turnover of INR 25 lakhs during three preceding financial years.
- c) Not engaged/involved/assigned/appointed in any capacity in WBSEDCL, presently and during three preceding financial years.
- d) Shall undertake not to take up any engagement/ involvement/ assignment/ appointment by WBSEDCL, if selected for this empanelment for the intensive audit till completion of the said assignment.
- e) Not blacklisted or debarred in three preceding financial years.
- f) Adequate professional staff strength including experienced partners and managers.
- g) Capability for handling large-volume data and evidence preservation.
- h) Office or establishment in Kolkata.

# 5. Evaluation Methodology

The rate should be quoted on lumpsum basis. The bidder quoting the lowest rate shall be declared as the L1 bidder.

6. Price Matching Clause

Not applicable.

### 7. Payment Terms

Payments shall be milestone-based:

- a) 25% of Fees on submission of Interim Report;
- b) 25% of Fees on acceptance of submitted Final Report;
- c) 50% of Fees on successful presentation and closure.

# 8. Completion Time

- a) Zero date shall be the date of acceptance of the of Letter of Award (LOA).
- b) Completion time shall be 60 days from the date of acceptance of Letter of Award (LOA).
- Interim Report shall be submitted within 30 days from the date of acceptance of Letter of Award (LOA).

### 9. Liquidated Damage

In the event of delay in completion of work, a sum equivalent to  $\frac{1}{2}$  % (half of one percent) per week subject to maximum of 5% of the awarded value shall be leviable as liquidated damage in form of deduction from amount payable in terms of the LOA.

# 10. Confidentiality & Data Security

The bidder selected for intensive audit shall ensure confidentiality of all documents and implement security measures for data handling. Disclosure requires prior written approval from WBERC.

# 11. Conflict of Interest

The bidders must disclose any relationship in line with stipulation at Clause 4 (c).

# 12. Forms, Annexures and Templates

The bidders must submit forms and annexures as specified, including Covering Letter, Firm Profile, Turnover, Assignments, CVs, Technical Approach, Declarations, EMD Form, and Price Bid Format.

# 13. Price Bid - Format (Part B)

The price bid must include lump-sum fee, applicable taxes, and validity of at least 120 days.

# 14. Security & Performance Guarantee

Earnest Money Deposit (EMD): INR 50,000 (Rupees Fifty Thousand only) in the form of Banker's cheque/Demand Draft drawn on scheduled Bank payable at Kolkata and payable

to West Bengal Electricity Regulatory Commission is to be submitted with the bid in a separate sealed envelope. Performance Guarantee: The EMD of the bidders selected for empanelment shall be held as Performance Guarantee.

# 15. Termination, Liability & Indemnity

WBERC reserves the right to terminate the contract for non-performance or breach. The bidder selected is liable for losses due to negligence or misconduct and shall indemnify WBERC.

# 16. Dispute Resolution & Governing Law

Disputes shall be resolved through arbitration in Kolkata under the Arbitration and Conciliation Act, 1996. This will have the jurisdiction of the courts in Kolkata and shall be governed by the appropriate laws in India.
